1. **TSWELOPELE LOCAL MUNICIPALITY: Upgrading of Bulk water supply Phase 3- Contract A-Bultfontein.**
2. **TSWELOPELE LOCAL MUNICIPALITY: Upgrading of Bulk water supply Phase 3- Contract B- Hoopstad.**

Tenders are invited for THE **Upgrade of Bulk water supply in both Bultfontein and Hoopstad**. NB these are two separate projects comprising more/less same scope in 2 different towns falling under the same Municipality.

Only cash payment at Municipal offices payable to **TSWELOPELE LOCAL MUNICIPALITY** shall be accepted. Interested Tenderers can obtain a document from Tswelopele Local Municipality, Bultfontein, from **12H00 on Friday, 28<sup>th</sup> August 2020**. Copies of the tender document will be available at the Municipal Offices [Bultfontein], Supply Chain Practitioner, Mrs Puseletso Loape.

Tenders in sealed envelopes and clearly indicating which project the bidder is bidding for, as per the example below: Tender No: **SCM / TSW /11A/PH3RBIG/2020/Bultfontein- Upgrade of Bulk water supply Phase 3- Contract A Bultfontein** or **SCM / TSW /11B/ PH3RBIG /2020/Hoopstad- Upgrade of Bulk water supply Phase 3- Contract B- Hoopstad**. The bidders are allowed to apply for both projects but, the bidding documents must be separate as per the Tender numbers provided in their independent envelopes.

Must be addressed to Tswelopele Local Municipality, and must be placed in the **Tender Box, Tswelopele Local Municipality, 1 Bosman Street, and Bultfontein** to be received at the mentioned addresses, **not later than 12H 00 on Monday, 28<sup>th</sup> of September 2020** which Tenders will be opened in public the same day in the offices of the Municipality.

There will be a Compulsory Briefing Session **Friday, 28<sup>th</sup> August 2020 at 12h00**. The Engineer will be present and any questions will then be answered. Persons taking interest will gather at the office of **Tswelopele Local Municipality, Bultfontein, Head Office, Council Chamber, at 12H00 [no late attendees will be allowed access to the meeting venue]**. **Tenderers who do not attend the compulsory briefing session will expose their Tenders to rejection**. Only tenderers who satisfy the eligibility criteria stated in the Tender Data are eligible to submit tenders. Tenders will be evaluated and adjudicated in line with the Supply Chain Management policy of the municipality using 80/20 preference point system.

Tenders must be registered with the CIDB in a **CE Class of Construction Works {Grade 6CE/5CE PE (Potentially Emerging Contractors) or higher}** and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with Regulation 25(1B) OR 25(7A) of the Construction Industry Development Regulation, 2004. **It is a condition of this tender that a 30% of the value of work must be given to a local sub-contractor (who is a resident within Tswelopele Local Municipal Area), the Municipality will facilitate such appointment in due course post the appointment of the successful Bidder.**

Tswelopele Local Municipality reserves the right to accept a part of a Tender and does not bind itself to accept the lowest and / or any Tender. Tender Prices must be valid for a period of 90 [ninety] days from the date on which Tenders are due. No Tenders or copies of Tenders received by facsimile machine, electronic mail or per telegram will be considered. Tenderers attempting to influence the Client with regard to the awarding of the Tender, after Tender closure, will automatically expose their Tenders to rejection.
